## Water Quality Report

This water supply obtains its water from the sand and gravel of the Pleistocene aquifer. The Pleistocene aquifer was determined to have low susceptibility to contamination because the characteristics of the aquifer and overlying materials provide natural protection from contaminants at the land surface. The Pleistocene wells will have low susceptibility to surface contaminants such as leaking underground storage tanks, contaminant spills, and excess fertilizer application. A detailed evaluation of your source water was completed by teh Iowa Department of Natural Resources, and is available from this water supply. **Our water quality testing shows the following results:**

## DEFINITIONS

**Level Goal**)-The level of a contaminant in drinking water below which there is no known or expected risk to health. MCLGs allow for a margin of safety.

AL (Action Level)-The concentration of a contaminant which, if exceeded, triggers treatment or other requirements, which a water system must follow.

MRDLG (Maximum Residual Disinfectant Level Goal)-The level of a drinking water disinfectant below which there is no known or expected risk to health. MRDLGs do not reflect the benefits of the use of disinfectants to control microbial contaminants.

MRDL (Maximum Residual Disinfectant Level)-The highest level of a disinfectant allowed in drinking water. There is convincing evidence that addition of a disinfectant is necessary for control of microbial contaminants.

**GENERAL INFORMATION** - Drinking water, including bottled water, may reasonably be expected to contain at least small amounts of some contaminants.
