Enjoy the peace of mind in knowing your seasonal property will not suffer damage due to frozen pipes this winter!

This program allows our seasonal customers to disconnect and reconnect their water service for a small fee of \$40.00. The fee includes both disconnection in the winter and reconnection in the spring.

Minimum monthly billing continues during seasonal disconnection, as noted within the signed service agreement and required by Board policy.

Winterizing a dwelling is the responsibility of the property owner. Our recommendation is that once the service has been disconnected, a professional plumber clears the service line of any remaining water.

A 24 hour notice is required for scheduling purposes although you may schedule without 24 hour notice for an additional \$75.00.

# A SPOTLIGHT ON OSGOOD

## ABOUT THE **PROJECT**

The Osgood Water Source Development Project includes the development of a water treatment plant (WTP) and well fields along the west fork of the Des Moines River, north of Emmetsburg, IA. The state of the art WTP will utilize reverse osmosis and pressure sand filter technology for treatment. The Iowa Department of Natural Resources reviewed and approved an independent pilot study completed by Harn RO and ILRW, confirming design parameters for the reverse osmosis system.

The WTP will be constructed in three phases, requiring two well fields located on the east side of the River. The North and Central Well Fields are scheduled to house nine production wells, with potential for a South Well Field at a later date. At final build out, the WTP will produce over 4.5 million gallons of safe drinking water per day. Water will be delivered to the plant for treatment through the construction of approximately 2.5 miles of raw water pipeline.

An estimated nine miles of finished mainline will be installed to transport the treated water between the Osgood WTP and a Ground Storage Reservoir and booster pump station, where it will then be pumped into the existing distribution system, as well as potential future developments.

The increased capacity coming from the Osgood WTP will be able to provide over 16,000 additional rural families with SAFE, DEPENDABLE, QUALITY water that will serve generations to come. IRLW is committed to improving access to sustainable, safe drinking water!
